MI Management is part of Mary Immaculate Health Care Services, itself a collection of entities and member of the Covenant Health System of Andover, Massachusetts. All officers, employees, executives, physicians, contractors and/or other labor providers who offer services to MI Management are legally and technically employed and compensated by either Covenant Health, Inc., or MI Nursing Restorative Center. MI Management does not file its own payroll reporting forms, including Forms W-2, 1099-MISC, or 1099-NEC.
