SMHS is part of the Covenant Health Inc. (CH) System; CH, a related organization and sole corporate member of SMHS, is the supported organization of SMHS. While SMHS may not directly transfer funds to or compensate CH, all of SMHS's activities and expenditures are in furtherance of both its own mission and the charitable purpose and mission of the Covenant Health System as a whole. Accordingly, 100% of SMHS's expenditures, other than those paid directly to Covenant Health Inc. for management services, have been classified as Other Support, as these costs were either paid on behalf of or in participation to the overall Covenant Health system and mission.

Part IV, Section A, Line 1:

The Organization was organized to operate exclusively for the benefit of, to perform the functions of, or to carry out the purposes of Covenant Health, Inc., other organizations within or affiliated with the Covenant Health System that are exempt as 501(c)(3) public charities under Section 501(a)(1) or 509(a)(2), and/or other organizations that are exempt as 501(c)(3) public charities under Section 501(a)(1) or 509(a)(2). But for the existence of the Organization, Covenant Health, Inc. would be responsible for the activities and services performed by St. Mary's Health System.

While Covenant Health, Inc. is specifically named in the Organization's governing documents, many of the affiliated entities within the broader Covenant Health System are not explicitly listed. However, as outlined in the preceding paragraph, Covenant Health, Inc. is the parent of the Covenant Health System. Any benefits provided to any entity within the System, either directly or indirectly, also benefit Covenant Health, Inc., the named Supported Organization. Therefore, while not all organizations that received support from the Organization are listed in the Organization's governing documents, any organization receiving support is part of a charitable class of supported organizations named in the Organization's governing documents through their affiliation, membership, and common-control relationship with Covenant Health, Inc.
