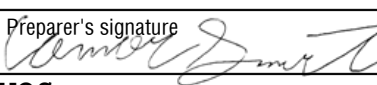

Youville Place provided 26,346 days of resident assisted living services. The organization follows the methodology that is recommended by the Catholic Health Association for calculating the cost of support for the broader community. In the methodology, the cost of providing services is reduced by payments received for services resulting in a net cost. It is the net cost of programs directed to the needy compared to the actual reimbursement for those services. Youville House had a total community benefit of \$1,131,428 of which \$1,121,081 were rents subsidized by the organization. These figures are 14.58% and 14.44% of operating expenses for the year of this return, respectively.
